I, the undersigned, by my signature on this document, hereby declare and agree as follows towards Gauteng Ice Hockey Association (GIHA), South African Ice Hockey Federation (SAIHF) or any sporting body to which GIHA is affiliated to or affiliated to GIHA i.e. Club:

1. I will be participating in certain activities hosted, facilitated or presented by GIHA (SAIHF OR Club), which may include, without limitation, any internal league programme, exercise, training and or evaluations ('the Activities').
2. I am aware that, as a result of my participation in the Activities described in clause 1, I may be exposed to situations that put me at risk, and I accept said risks voluntarily and undertake at all times to act with all due caution and to take the utmost care to limit the risks involved.
3. I will strictly abide by all applicable GIHA (SAIHF or Club) rules and policies, and otherwise to adhere to any instructions issued by GIHA (SAIHF or Club) relating to my participation in the Activities.
4. Have willingly chosen to play /officiate / practice ice hockey in the full knowledge of these facts;
5. I acknowledge and agree that I will not have any action or claim of whatsoever nature against GIHA (SAIHF or Club) or any of its officials, employees or agents, for any injury, illness, damage or loss of any nature whatsoever that I or my property may sustain and which directly or indirectly results from my participation in the Activities, from any act or omission by GIHA (SAIHF or Club) or any of its officials, employees or agents (save for negligence on the part of GIHA (SAIHF or Club) or its such officials, employees or agents), or otherwise. I shall moreover defend, indemnify and hold harmless GIHA (SAIHF or Club) and its officials, employees and agents for and against any action or claim brought by any person (including, without limitation, my spouse, children or any other dependent) as a result of any injury, illness, damage or loss suffered by me in such circumstances as are set out hereinabove.
6. I shall defend, indemnify and hold harmless GIHA (SAIHF or Club) and its officials, employees and agents for and against any claim of whatever nature instituted against GIHA (SAIHF or Club) or any of its officials, employees or agents by any person as a result of any injury, illness, damage or loss caused by my willful or negligent conduct or omission, or that of any person for whose actions I am or may be deemed to be responsible.
7. I shall be liable to GIHA (SAIHF or Club) for any damage or loss caused to GIHA (SAIHF or Club) as a result my willful or negligent conduct or omission, or that of any person for whose actions I am or may be deemed to be responsible.
8. I understand and give permission that photographs of minor players will be taken during practice sessions, games and other events.

- Playing in men's league, the IIHF rules of such league will apply in full.
 - No special consideration or exemptions are provided or implied by allowing woman (girl) players to participate in the men's (boys) league.
 - Where such league plays full contact rules, these rules will also apply to woman players who wish to participate in the league.
